

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <http://medmyway.com/> and MedMyWay, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to MedMyWay, LLC include <http://medmyway.com/> and MedMyWay. Collection of your Personal Information

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through MedMyWay's public message boards, this information may be collected and used by others.
